FEICA Regulatory Desk

FEICA publishes a position paper on ELVR

FEICA responded to the European Commission's mentioning of adhesive and sealants as a challenge for car dismantling in the 'ELV Regulation proposal' (COM 2023/451). FEICA's position asks also for changing the wording of the definition of 'plastic' in the Regulation proposal to align with the definition provided in Directive (EU) 2019/904. FEICA confirmed as a CEN Liaison Organisation

FEICA will contribute to the technical activities of CEN/TC 442 'Building Information Modelling (BIM)'. The observer role of the organisation will provide feedback on the requirements for adhesives and sealants specific product data in relation to crucial topics such as the Digital Product Passport (DPP), new data model specifications and their interoperability aspects. FEICA is part of the ECHA's CLP Regulation Expert Group

Paula Diaz, FEICA Senior Regulatory Affairs Manager, is now a member of the Expert Group of the European Chemicals Agency (ECHA) in charge of updating the Guidance on Labelling and Packaging. Paula's work will be supported by FEICA experts to effectively communicate the challenges and opportunities for the industry.

FEICA contributed to discussion on Substitution Planning

Paula Rodriguez, FEICA Senior Regulatory Affairs Manager and DUCC Chair, joined the European Commission's Workshop on Substitution Planning together with some FEICA members and Triin Kaup, DUCC manager, to share the downstream users' perspective on substitution issues with the European Commission, NGOs and other industry associations.
