GREEK ADHESIVES AND SEALANTS PRODUCERS FORM ASSOCIATION

On 8 December 2021, representatives of the Greek adhesive and sealant industry came together to found the Hellenic Adhesives and Sealant Cluster (HASC), under the umbrella of the Hellenic Association of Chemical Industries (HACI).

As of January 2022, Greece joined the many other EU countries which have a national association representing the adhesives and sealants manufacturers vis-à-vis authorities.

The inaugural meeting focussed on the legal formalities of the founding of the Association and the election of the first Administrative Committee. Panos Scarlatos, General Director of HACI, and Kristel Ons, Secretary General of FEICA have offered continuing support to the Cluster.

FEICA WEBINAR ‘How to keep on top of increasing data requirements’

On 2 February 2022, FEICA organised the webinar with, among other experts, the participation of Ms Eva Kaili, Vice-President of the European Parliament.

Dimitris Soutzoukis, Senior Regulatory Affairs Manager at FEICA, provided an overview of the current situation highlighting the issue of increased data circulation in the A&S supply chain, which sometimes results to confusing and not understandable labels. He touched on a variety of topics, including data flows today, the organisation of product data, and principles to be followed regarding the appropriate and efficient handling of data.

After the overview, Mr Marko Susnik, Senior Advisor at WKÖ, the Austrian Federal Economic Chamber, & Advisor to the Secretary General on Chemicals Policy, SMEunited, presented SMEunited's perspective on digitalisation. Having noted the place and the heterogeneous character of small and medium-sized enterprises (SMEs) in Europe, Mr Susnik focused on the different support measures required for them in terms of levels of digitalisation and size, for example, skills development, financial support and ensurance of the proper infrastructure.

Following Mr Susnik, Mr Senthil Pichandi, Vice President, Global Product Safety & Regulatory Affairs at Henkel, considered industry views on regulatory data requirements. He analysed the complexities of data flow (from suppliers to customers), data requirements (e.g., regulatory and industry-specific) and increasing data needs (as a result of the European Green Deal). While presenting his section, a participant survey* was conducted that also validated the growing trend of increasing data requirements within the industry.

Next Mr Ronald van den Bosch, PU EH&S and Circular Economy at Dow Benelux BV, showed the capabilities of the ChemChain Block-Chain data model by the use of a value chain example. Having presented the model in terms of the product elements (substance, mixtures, articles) and the transaction in terms of its elements (product, receiver, invoice or transaction reference), he then demonstrated the model's capabilities through the use of a flow chart tracking the product life of polyurethane insulation from the use of additives and substances, to the manufacture of the foam and of the flexible foam mattress, to the end of life in recycling.

FEICA takes opportunity to inform Ms Kaili, Vice-President the European Parliament, about A&S industry concerns, and introduced FEICA as an active EU stakeholder with respect to increasing data requirements.

The webinar was capped off with a talk by Ms Eva Kaili, Vice President of the European Parliament, who shared her views on digitalisation and blockchain. Ms Kaili spoke of the need for a flexible and balanced approach regarding the handling of data. She noted the importance of ensuring the quality and safety of data, and underlined the European Union's ambition to remain competitive globally in the digital arena. She then gave a brief overview of EU-level initiatives aimed at harmonising and increasing data flows in the EU in a safe and reliable way. At the end of the webinar there was a very interesting Q&A session.

Overall, the webinar had three main messages.

First, it introduced for debate the problems the A&S sector is having (e.g., digital landscapes, and increased volumes and regulations).

Second, the industry has stressed such issues as security, quality and availability of data.

Third, effective product data must be structurally and securely organised, interoperable, and verifiable as regards everyone in the supply chain.

NOTIFICATION OF POLYMERS

FEICA leaflet 'Defining a reasonable, safe and efficient system for the notification of polymers' now available in 7 languages

In issue 46 of CONNECT, we informed our readers that a FEICA leaflet on the notification of polymers had been published. The European Commission is working to extend registration requirements for polymers, currently exempted from registration under EU REACH, and it is considering requesting industry to notify of certain polymers' information. FEICA therefore produced a FEICA leaflet to explain why the notification of polymers should be limited to a concise dataset and analytical or test data should not be required at the notification stage.

A MORE RESILIENT, GREEN & DIGITAL CONSTRUCTION ECOSYSTEM

FEICA contributes to EU Stakeholder consultation

The Commission proposed to co-create, in partnership with industry, public authorities, social partners and other stakeholders, transition pathways for ecosystems, where needed. Construction has been recognised to be one of these critical ecosystems and it was therefore tackled first, by co-creating its transition pathway together with its stakeholders. The Commission services have prepared a Staff Working Document (SWD) to outline possible scenarios for a transition pathway for a more resilient, green and digital construction ecosystem and launched a consultation.

FEICA, in coordination with Construction Products Europe, has contributed to the EU Stakeholder consultation on the SWD "Scenarios for a transition pathway for a more resilient, greener and more digital construction ecosystem".

THE IMPACT OF BREXIT ON EUROPEAN UNION COMPANIES: KEY QUESTIONS

A year has passed since the signing of the EU-UK Trade and Cooperation Agreement on 20 December 2020. This Agreement was to safeguard the interests of the European Union and to foster co-operation between the EU and the United Kingdom in the wake of the UK's withdrawal.

European Union countries remain anxious about the effect of regulatory divergence due to Brexit. Of particular concern is the transitioning of legislation regarding chemicals. For instance, the United Kingdom's temporary acceptance of previously approved EU chemicals via its 'grandfathering' option avoids duplicating data collection for the EU Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), but this is applicable only for UK-based holders of EU REACH registrations at any point after 29 March 2017 and before the end of the Transition Period. This is also a deferment of the intended 're-registration' process, and the current legislation, if it is not amended, may still require data duplication and places a new burden on UK downstream users due to the much smaller market size and structure.

There are, then, two key questions regarding the impact of Brexit on EU companies: What is the perspective of the EU industry on regulatory divergence, and what key trade concerns and anticipated market trends will arise?

Regarding the first key question on divergence of regulation, improvements are needed as regards the sharing of data. For one thing, because the United Kingdom is unable to gain access to the REACH database of the European Chemicals Industry (ECHA), on the one hand, a costly, duplicative re-registration process for UK companies is foreseen.

In the EU, on the other hand, downstream users buying chemicals from UK companies could be faced with the prospect of needing to register these chemicals themselves. Furthermore, also regarding divergence of regulation, better guidance is needed concerning downstream user import notifications (DUINs). Eventually, because DUINs merely suspend UK-REACH obligations for 2, 4, or 6 years, all chemicals will be required to be registered in terms of UK-REACH. In addition, if a raw material supplier or Only Representative has submitted the original DUIN, then alternative or new suppliers of the same substance would have to be covered by an immediate registration (New Registration of an existing substance, NRES) and are not covered by the existing DUIN. Also, the suspension/deferments are going to be extended whilst DEFRA and HSE consult with industry and NGOs about a better way to deal with chemical registration (<https://www.basa.uk.com/Home/News/1550>). The talk is that all the current deadlines will be extended two years.

The second key question regarding Brexit's impact on EU companies involves trade concerns and market trends that will likely arise. Trade concerns are numerous as economic uncertainty results from regulatory uncertainty. All of the following are anticipated regarding trading: Shipping costs are higher; custom border requirements are more complicated because of, for example, new customs declarations required; issues regarding rules of origin clauses come into play so that in some cases importers have to pay tariffs twice; shipments get delayed because paperwork is lacking, and containers are in short supply; raw material imported into the United Kingdom costs more.

Besides the trade concerns, three market trends can be noted.

1/ There has been a downturn in the percentage of direct investment in the United Kingdom in the five years leading up to March 2021 (an increase of only 12 % compared to the prior five years). In European Union countries, by contrast, the increase was 33 %.

2/ UK companies are moving their production operations to the EU to supply these 27 countries. (An EU company, for example, set up a subsidiary in Poland to service the EU bloc, and a German company cancelled plans to further invest in its UK factory.)

3/ Companies in the European Union are moving their imports from UK-based to EU-based companies.

Results of the FEICA poll

A membership poll taken in October 2021 by FEICA revealed concerns among members about trade and divergence of regulation following Brexit.

According to the poll, there are two top concerns regarding trade: Worries regarding the costs of transport and the availability of transporters, and concerns about divergence of regulation.

First there are worries regarding the costs of transport and the availability of transporters: Shipping costs have gone up, and drivers are too frequently unavailable. (Also, overturn time at the border crossing is excessive.) Additionally, importing and exporting bring further costly administrative duties. For example, because of the way DUINs are submitted by 'only representatives' (ORs) in the United Kingdom, different production plants must ensure that the UK OR appointed submits separate DUINs for each EU plant (using a 'child' account set up under their own 'parent' 'Comply with REACH IT' account).

The FEICA membership poll also revealed mushrooming concerns about divergence of regulation. The result of regulatory changes in the future will probably be substances being classified in different ways. Classification and labelling lists will likely diverge.

Assuming Classification, Labelling and Packaging (CLP) Adaptations to Technical Progress (ATPs) are dealt with separately, the result will be differing product formulations, certifications, compliance rules, labelling, and product packaging in the European Union and the United Kingdom. All this will increase costs substantially.

Further issues involve a divergence in health and safety rules, the status of CE markings after 2023, and the lack of agreement surrounding the issues of product testing (CE versus UKCA markings), as well as the uncertain situation involving the matter of retesting and reclassification of products (for the UKCA marking).

We asked Philip Bruce, FEICA Secretary General from 2016 to 2020, and Roberto Leoni, retired member of the FEICA Executive Board, to answer a few questions in celebration of our 50th anniversary

Philip, when you think of FEICA, what is the first thing that springs to mind?

A professional and energetic team that works to help support the members and the adhesive and sealant industries they serve.

What do you believe to be FEICA's greatest achievement whilst you were at FEICA?

Tackling some of the more restrictive legislation proposals to make the outcomes workable and acceptable for the industry which involved other European sectors, with the Commission and European governments via country associations. Examples of adhesives in electronics, Paper packaging and the advocacy on Isocyanates where we ended by offering a direct electronic solution to members to enable compliance to regulations in the sector. The strategy development where a clear focus on the Green Environment was successful positioning our sector and members as enablers to the new direction to be followed.

When we had the Conferences I believed they provided an excellent networking event to strengthen the sector overall - a real benefit to the members!



Roberto, how were you involved with FEICA in the past?

I joined FEICA in 1989, initially as an AVISA delegate in several technical working groups and then as a member of the European Technical Board (ETB) since its creation. I was elected as AVISA delegate in the European Executive Board (EEB) in the '90ties' and maintained this position until 2018. I had an active role in all FEICA meetings of both the EEB and ETB.

When you think of FEICA, what is the first thing that springs to mind?

Open, fruitful and lasting collaboration between all of the active FEICA members.

What do you believe is FEICA's greatest achievement?

Networking, experience exchanging, and discussion on common present as well as future possible problems among colleagues of European adhesive and sealant industries.

How do you see FEICA's future?

This is a difficult question. The European Union isn't yet a well-consolidated Union from many perspectives. Even the recent COVID-19 pandemic has clearly shown the incapacity to reach a common answer for the different EU countries. We need to work towards a wide European vision. The new geopolitical situation (Russia-Ukraine, China-Taiwan....) risks having a serious impact on the European economy and on our companies.

In this scenario FEICA could and should be the tool capable of strengthening cohesion among its members and helping them to identify the most suitable targets to face problems with a truly European vision.
