How digitisation accelerates R&D and innovation in the adhesives and sealants industry - CONNECT interviews Aldric Tourres of SpecialChem.

FEICA is delighted to welcome back to the Conference **Aldric Tourres**, Executive Vice President, Head of Sales & Marketing, SpecialChem.

This year, Aldric will share his insights into how digitisation can speed up and improve R&D and innovation in our industry. **CONNECT spoke to Aldric to get a preview of some of the key themes he will be discussing at FEICA 2017 in Sardinia.**

CONNECT: You talk about companies "digitally plugging into their growth markets", and "capitalising on specialised online networks". Could you expand on these concepts a bit more?

Tourres: Everyone has a network of clients, suppliers and other stakeholders. Of course, networks have existed outside the digital world since the beginning of time. To give you a couple of examples: networks in academia have been around since long before the digital age, and have now evolved to exploit the benefits offered by digitisation to improve collaboration. LinkedIn is an example of a general "digital network", whereas SpecialChem of course facilitates a series of specialised networks in the chemicals sector sector including our networks in coatings, adhesives and sealants.

You may have frequent contact with your network, but more

often than not, this contact is ad hoc, and there are probably some players in your network that you have no contact with. In short, communicating about a project in an efficient and timely manner with all the players that could potentially contribute to its success is impossible, and that's where digitisation comes in.

CONNECT: What are the benefits of digitisation?

Tourres: Currently the R&D process is long and inefficient. People are wary of investing. Digitisation allows you to build a community with all stakeholders and to exploit that community much more fully and quickly. You can bring in the voice of the market much earlier to deliver faster, more comprehensive and beneficial collaboration. **CONNECT:** How does this relate to the stagegate process?

Tourres: In my view, the traditional stagegate process is dead! In its place, I propose a model I like to call the "porous stagegate process". The essential features of this model are that it:

- Allows you to connect to the end-market and easily adapt a project to perfectly meet the needs of the end-market.
- Allows you to get external parties to contribute to the R&D process.
- Allows multiple rounds of rapid, iterative development; something that was previously impossible without costing lots of time and money. This accelerates R&D and at the same time delivers better results.

Of course, digitisation will not replace the need for good people. On the contrary, it is digitisation combined with human interpretation that will make the difference.

CONNECT: Where does this concept come from and what's the evidence for its success?

Tourres: You can consider it a form of agile development inspired by the IT industry, which successfully uses short, iterative development loops in the software development process. SpecialChem has adapted the methodology and successfully applied it in the speciality chemicals sector.

CONNECT: Do you see any challenges in applying this methodology to the adhesives and sealants industry?

Tourres: The adhesives and sealants industry is very traditional and I'm not here to scare people! Digital is not here to replace human interaction, but to improve the speed and efficiency of those interactions. Digitisation is already happening in the adhesives and sealants value chain. Building on its work with leading adhesive and sealant raw materials suppliers such as Evonik, BASF, Dow and Dynasol over the last 16 years, SpecialChem is now discussing digital transformation strategies with some of these companies. Once people see proof of concept in closely related businesses, they will be keen to learn what digitisation can do for their business. I'm sure my presentation will provide the Conference delegates with plenty of food for thought!

FEICA's latest Food Contact Material (FCM) Guidance translated

FEICA recently published a guidance document on evaluating the food contact status for adhesives containing **mineral oil hydrocarbons.**

The 'FEICA guidance related to the food contact status of adhesives and mineral oil hydrocarbons' will help industry and regulators to better understand the challenges and possible solutions to testing mineral oil hydrocarbon migration from adhesives.

The guidance has now been translated into German, French, Spanish and Italian.

Promoting the safe use of chemicals

EU citizens' perceptions of The key findings include: chemicals safety

It was ten years ago that REACH legislation came into force, replacing more than 40 pieces of European chemicals legislation with a single law.

One of the aims of REACH is to increase consumer and investor confidence, as well as employee and community trust, thus creating a more positive business environment and a more competitive, innovative, and economically sustainable chemical industry. To assess progress in this area, the EU Commission carries out regular "Eurobarometer" surveys of EU citizens' awareness of the safety of chemical products. The most recent survey interviewed almost 28,000 people from the 28 Member States in November and December 2016, and reveals the impact REACH has made in its 10 years' existence.

The main findings were presented by Elżbieta Bieńkowska, Commissioner for the Internal Market, Industry, Entrepreneurship and SMEs, at a recent chemicals forum celebrating <u>ECHA's 10th</u> <u>anniversary</u>.

- 44% of EU citizens consider that safety of chemicals contained in products has improved in the last 10-15 years. They also have a higher level of confidence in products manufactured in the EU compared to those imported from outside.
- However, less than half of respondents say they feel well informed about the potential dangers of the chemicals contained in consumer products.

Although a lot of progress has been made, there is a continuing need to better inform EU citizens and address their concerns.

FEICA's commitment to ensuring the safe use of chemicals

Ensuring the safe use of chemicals is one of the major objectives of FEICA, which, together with the Downstream Users of Chemicals Coordination Group (DUCC), has being working on a number of solutions (tools and templates) to help formulators comply with REACH, while ensuring that proper safe use data is communicated along the supply chain and, ultimately, implemented.



In this context, FEICA has been proactive in creating accurate information for adhesives and sealants applications to **facilitate both the upstream communication** (for registrant's Chemical Safety Assessments) **and downstream communication** to endusers of adhesives and sealants products.

FEICA is proud to have been the first signatory of ECHA's Chemical Safety Report/Exposure Scenario (CSR/ES) Roadmap to publish Use Maps, which comprise the majority of adhesives and sealants applications.

FEICA developed these and related exposure packages exposure assessment inputs for workers (SWEDs), consumers (SCEDs), and the environment (SpERCs) - to provide clear and concise information about use and use conditions of typical adhesives and sealants to registrants.

Another milestone for FEICA, as part of a joint effort with DUCC, is the development of the Safe Use of Mixtures Information (SUMI), which facilitates the information flow downstream to end-users – i.e. professional and industrial workers.

Using this SUMI template, FEICA has created a set of documents describing the operational conditions, risk management measures and best practice for using typical adhesive and sealant products.

They provide the "product's safe use information" in a simplified and tailored manner, allowing workers to better understand and adopt any necessary measures.

Although SUMIs do not replace the Safety Data Sheet (SDS), they can be appended to or integrated within the SDS of the mixture. Together, the two documents form a concise package that allows end-users to use a product safely.

These developments are part of FEICA's commitment for 'improving the safe use of chemicals in Europe through excellence in supply chain communication', and to that aim, FEICA will continue raising awareness of developments to support registrants in generating meaningful exposure scenarios.
