ASC, CATIA, and FEICA announce revisions to joint adhesives and sealants classification manual

Effort Intended to Maintain Harmonised Terminology and Market Segmentation

The Adhesive and Sealant Council (ASC), FEICA (the European voice of the adhesive and sealant industry), and the China Adhesives and Tape Industry Association (CATIA) have partnered to update and harmonise adhesive and sealant industry terms, definitions and market segmentation published in the ASC-CATIA-FEICA Adhesives and Sealants Classification Manual.
