FEICA WEBINAR: 25 FEBRUARY 2021

CONSTRUCTION PRODUCTS REGULATION (CPR) REVIEW

Following the recent public consultation on the review of the European Construction Products Regulation (CPR), FEICA is organising a webinar to raise awareness about this legislative package within its membership and interested stakeholders.

An overview of the present situation and the important scenarios and policy options for CPR will be presented by Deutsche Bauchemie Director, Mr Martin Gloeckner, followed by a summary of the recent Committee on the Internal Market and Consumer Protection (IMCO) report by Member of the European Parliament (MEP) Christian Doleschal.

Mr Doleschal, who is the rapporteur of this action of the European Parliament, will present the main outcomes of the IMCO report, which focuses on the present and future of the CPR.

Views on the CPR review will be shared by the Netherlands Ministry of the Interior and Kingdom Relations (BZK) Senior Policy Officer-Building Regulation, Drs Dirk Breedveld (MSc).

FEICA PUBLISHES POSITION PAPER ON THE REGISTRATION OF POLYMERS

FEICA highlights the importance of a reasonable and workable approach to the extension of registration requirements to polymers

The recently published FEICA position paper explains the perspective of the adhesives and sealants industry regarding the registration of polymers.

Polymers are currently not included in the registration requirements under Regulation (EU) No. 1907/2006 - Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH). However, in terms of Article 138(2) of REACH, a possible further review is foreseen to extend the registration requirements to polymers. If the risk posed by certain polymers can be proven, and practical and cost-efficient ways of selecting polymers requiring registration (PRR) can be established, registration requirements under REACH will be extended to polymers.

FEICA published the perspective of the adhesives and sealants industry in a Position Paper as several relevant parameters need to be considered regarding a proposed registration of polymers.

EUROPEAN CHEMICALS AGENCY (ECHA) COMPLETES ROADMAP TO ADDRESS SUBSTANCES OF VERY HIGH CONCERN (SVHC)

As part of the SVHC 2020 Roadmap launched by the Council of the EU in 2013, all relevant, currently known substances of very high concern, have been identified and included on the Candidate List.

Following its completion, ECHA also published a <u>brochure</u> summarising the achievements of the SVHC 2020 Roadmap.

The goal of the SVHC Roadmap was to identify all relevant, currently known substances of very high concern (SVHCs) and include them on the Candidate List by 2020. The Candidate List now contains 211 substances.

The roadmap also aimed to efficiently identify new chemicals of concern. EU Member States and ECHA have systematically screened information on registered substances. By the end of 2020, Member States had carried out regulatory management option analysis (RMOA) on around 220 chemicals of potential concern and identified a need for further regulatory action for about 80 % of them.



FEICA UPDATES USE MAPS TO HELP IMPROVE COMMUNICATION UNDER REACH

An important part of FEICA's work is related to REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals). The fundamental aim of the REACH Regulation is to improve the protection of human health and the environment from the risks that can be posed by chemicals, while enhancing the competitiveness of the EU chemicals industry.

To help FEICA members and other actors in the supply chain to comply with the regulatory requirements, it developed Use Maps and related exposure packages (SWEDs, SCEDs, SpERCs) to provide information about use and use conditions, and SUMIs to provide safe use advice to end-users. to support.

In January 2021, a new version of Chesar, the European Chemical Agency's (ECHA) chemical safety assessment and reporting tool, was released. Chesar 3.6 implements a set of harmonised conditions of use (CoU) for workers assessment.

This new set of workers CoU affects the structure of the Sector-specific Worker Exposure Descriptions (SWEDs), and consequently FEICA use maps.

Therefore, updated files have been made available in <u>ECHA's use</u> map library and on the <u>FEICA website</u>.

FEICA invites all Chesar users who have used these use maps in their assessments to import the updated version in Chesar 3.6 as soon as possible.

Chesar 3.6 is available for download via the ECHA website.

CHESAR 3.6

CHESAR (CHEmical Safety Assessment and Reporting tool) is an application that helps companies to carry out their Chemical Safety Assessments and to prepare their Chemical Safety Reports and Exposure Scenarios for communication in the supply chain. '3.6' is the latest version of Chesar.



FEICA TO PRESENT AT CHEMICAL WATCH EVENT ON 23 MARCH 2021

'Key Regulatory Updates: Europe, Asia and the Americas 2021'

The Chemical Watch Conference, which will take place from 23 to 25 March 2021, aims to summarise the latest regulatory challenges facing those working in the safe management of chemicals. Paula Diaz, Regulatory affairs manager at FEICA, has been invited to speak at the conference on the extension of the registration requirements to polymers under the REACH Regulation. Together with a general overview of the regulatory process and expected timeline, Paula will highlight the challenges that the extended registration requirements could pose on the customisation of polymers.

In addition to the registration of polymers, other topics covered will include updates from the EU Commission and on the EU Chemicals Strategy for Sustainability, Brexit and UK REACH and regulatory changes in Asia, United States and Latin America.

BREXIT: IMPORTANT CONSEQUENCES FOR OUR INDUSTRY

Now that the BREXIT transition period has ended, it is important that companies take prompt action to ensure any remaining UK registrations not already transferred to EU-based entities are transferred as soon as possible.

By the deadline of 31 December 2020, registrants had failed to initiate a transfer of some 2,900 registration dossiers held by UK companies, representing some 20% of all registrations from the country. In addition, 268 substances that were only registered by a UK-based company had not been transferred to the EU and the corresponding registrations will be revoked. In terms of the potential market impact, it should be noted that about 60 % of these were registered only for intermediate use, meaning that they are used in the manufacture of other substances and transformed into them. The European Chemicals Agency (ECHA) will immediately start revoking these registration dossiers.

According to ECHA, the number of UK registrations facing revocation could rise further if transfers that had been initiated by the end of the year are not accepted by the EU successor entities by 31 March 2021.

This is in line with the EU Implementing Regulation on dossier updates, which prescribes that companies need to update registration information, such as a change in legal entity, within three months.

A trade deal between the UK and the EU was agreed on 24 December 2020, one week before the end of the transition period. A chemicals annex to the deal excludes the possibility of using ECHA data for the UK REACH registration.

ECHA maintains a list of substances only registered by UK companies. This list is available as an Excel spreadsheet on ECHA's website. Information contained in the UK registrations will stay on ECHA's website after the revocation, but the registration status will change. The spreadsheet is available on the <u>ECHA website</u>.

A SAFE FUTURE FOR POLYURETHANE (PU) PRODUCTS AVAILABLE IN 8 LANGUAGES

On 4 August 2020, a new restriction on diisocyanates was adopted by the European authorities under REACH. The FEICA PU Restriction Technical Working Group (TWG) created the leaflet in order to provide more information for our industry regarding the restriction.

The leaflet has now been translated, from English, into German, French, Polish, Italian, Dutch, Spanish and Slovenian.

FEICA, in coordination with ISOPA and ALIPA, the diisocyanate manufacturers' industry associations, is preparing training material for use by its members and by adhesive or sealant users. We expect it to become available as of February 2022, early enough for all users of polyurethane (PU) products to be trained and certified by 24 August 2023. In addition, the legal requirements should appear on packaging as of 24 February 2022.

WAC 2022 will take place in Chicago from 25 to 27 April 2022


The global conference is held once every four years and rotates between Asia, Europe, and North America.
