## “Pursuing Growth – Strategic Choices in a Rapidly Changing World”



### The 2016 FEICA Business Forum covered, in depth, strategies for growth in a turbulent world

Four highly regarded keynote speakers presented indispensable insights into our rapidly changing world.

Professor **Rob Holdway**, Director of Giraffe Innovation Ltd, described how innovation for the circular economy requires a revolutionary co-design approach to move from a linear to a circular model encompassing the way in which we design, manufacture, sell and consume products and services. This presents great opportunities although it won't be easy to move away from conventional business models.



**Charles Dhanaraj**, Professor of Strategy and Global Leadership at IMD in Lausanne, examined how the quest for growth is taking place against the backdrop of important social and technological trends that are redefining the world today. New markets are emerging and new needs are arising. Based on an ongoing research project at IMD, Professor Dhanaraj presented some novel ideas on how to pursue growth.

**Aldric Tourres**, Vice President at SpecialChem, covered how to reduce risk and accelerate growth in new applications and unfamiliar markets. He recommended the implementation of an iterative process that employs both digital and human methodology. To successfully implement this process, specific assets including market connection, multidisciplinary

organisational resources, and efficient partner selection criteria must be in place.

Finally, **Dr Achim Hübener**, CEO of Klebchemie, explained that because today's business environment is subject to constant change, it is essential for businesses to quickly identify the impact of such rapid changes on their own business, and capitalise on opportunities in order to achieve business growth.



## REACH-IT tools – latest developments

“Preparing the registration dossier” is the fifth phase of ECHA’s REACH 2018 Roadmap.

Below we outline the latest developments in the IT tools provided by ECHA to help facilitate registration.

Information on the identity, hazards, uses and risks of substances compiled in previous phases of ECHA’s REACH 2018 Roadmap must be documented in a standardised IT format in registration dossiers.

### IUCLID 6

IUCLID (International Uniform Chemical Information Database) is a software application to record, store, maintain and exchange data on intrinsic and hazard properties of chemical substances. **It is the tool used to prepare, for example, REACH registration dossiers and applications for authorisation of biocidal products.**

### How to create your registration dossier in REACH-IT

If you are a member registrant and you agree with all the information submitted by the lead registrant on your behalf, you can prepare your registration dossier in REACH-IT - without having to install IUCLID.

New versions of both software packages have been launched recently.



### CHESAR 3

CHESAR (CHEMical Safety Assessment and Reporting tool) is an application that helps companies to carry out their Chemical Safety Assessments and to prepare their Chemical Safety Reports and Exposure Scenarios for communication in the supply chain.

Version 3 of Chesar includes additional functionalities both for the environmental and human health assessments, for example, the possibility to edit several contributing scenarios at the same time when the same changes apply to all of them. The help text has also been integrated in the application and generating your Chemical Safety Report (CSR) will also be easier. New features include, among others, the generation of ES for communication in EComXML format, SWEDs and use maps support.

Any assessments carried out with Chesar 2 will automatically be migrated to Chesar 3.

Chesar 3 will be updated and released the second week of November to be fully compatible with IUCLID 6. More information can be found here:

## FEICA publishes Use Maps to help improve communication under REACH

By signing the CSR/ES charter ([https://echa.europa.eu/documents/10162/15669641/csr\\_es\\_roadmap\\_statement\\_of\\_intentions\\_en.pdf](https://echa.europa.eu/documents/10162/15669641/csr_es_roadmap_statement_of_intentions_en.pdf)), FEICA confirmed its support to deliver the Roadmap plan of action.

**Since then, FEICA has been an active contributor to the development of aspects of the Roadmap aiming to improve the communication on safe use of chemicals along the supply chain.**

As a result, and being a downstream user sector association, FEICA has developed Use Maps and related exposure packages (SWEDs, SCEDs, SpERCs) to provide information about use and use conditions, and SUMIs to provide safe use advice to end-users.

### The FEICA Use Maps comprise the majority of industrial and professional applications of the adhesive and sealant sector

The Use Maps help registrants to understand how substances are typically handled in the adhesive and sealant industry. They aim to support Chemical Safety Assessments under REACH that reflect *relevant and realistic* information on adhesives and sealants.

### Use Maps are typically generated by downstream user sector organisations, in order to ensure representation.

The FEICA Use Maps provide, in a harmonised and structured way, information on typical uses and conditions of use of adhesives and sealants that aim to support registrants in generating meaningful exposure scenarios.

## Member States agree to harmonise Poison Centre information

The legal obligations relating to the submission of information to the appointed bodies (Poison Centres) are laid down in Article 45(4) of Regulation 1272/2008 ('CLP Regulation'). See [http://ec.europa.eu/growth/sectors/chemicals/poison-centres\\_en](http://ec.europa.eu/growth/sectors/chemicals/poison-centres_en)

Currently the information that needs to be submitted to Poison Centres across the EU can vary widely between Member States, as each individual country sets its own legislation regarding this information. This has resulted in a significant administrative burden for industry, leading to inconsistent information across member states concerning chemical products and their inherent hazards.

To resolve this issue, Member States have voted in favour of the European Commission's proposal to harmonise the information provided to Poison Centres. This proposal also establishes the format for the submission of information (harmonised XML format to facilitate harmonised submission requirements). In addition, it includes a Unique Formula Identifier (UFI) that will allow Poison Centers to rapidly identify the product involved and its composition, as well as an European Product Category System (PCS) to facilitate the transmission of information on the product's intended use in support to the statistical analysis regarding poisoning cases.

**The regulation is expected to be in force for consumer mixtures by 2020, professional products by 2021 and industrial products by 2024.**

**In the meantime, ECHA has created a Poison Centres website where companies and Member State Competent Authorities can use a draft format to prepare for the submission of information to Poison Centres.**

## New (and final) set of European Model EPDs available for our members

### All FEICA EU Model EPDs have now been completed!

Rather than covering a particular range of products, EU Model EPDs are structured according to chemical composition and cover all products within a certain range of formulations and applications.

As the environmental impact of an adhesive or a sealant to a building is comparatively low (below 1%-3%), any differentiation between products would not contribute any more meaningful information due to the complexity of the system.

FEICA members and their members can declare that one or several of their products are covered by an EPD. In order to do so, they will need the FEICA guidelines that our members can request via: <http://www.feica.eu/our-priorities/key-projects/epds.aspx>

### What is an EPD?

An Environmental Product Declaration is a comprehensive report created to internationally agreed standards (e.g. ISO 14025, EN 15804, etc.) which documents the ways in which a product affects the environment throughout its life cycle.

## Adhesive and sealant Good Practice articles

### Helping to raise awareness of the industry's contribution to a sustainable future

The adhesive and sealant industry is subject to increasing pressure from downstream users, upstream suppliers and EU legislators to become more sustainable.

**FEICA's sustainable development committee agreed that FEICA should support the industry in the face of this pressure and demonstrate to EU policymakers and value chain stakeholders that our industry is committed to sustainable development and continues to make strides in contributing towards a sustainable world.**

To help with this objective, it was decided to create "good practice" case studies that demonstrate specific examples of how the industry is making a contribution towards a sustainable future. Creating positive stories of this nature had been an objective of FEICA for some time. The challenge had always been how FEICA could gather and re-use the great materials from adhesive and sealant companies, but be seen to remain neutral and not promote specific companies, while still providing some form of acknowledgement for the contributing companies.



### **"Good practice stories" – a new tool to aid the communication of sustainable development**

A new tool was born that met these criteria – the "good practice stories".

According to Heinz-Werner Lucas, FEICA Expert, who has been coordinating the creation of the first batch of good practice stories, "These take some of the communication materials from member companies that describe their notable products or process improvements that deliver sustainability benefits and create a brief, neutral summary that FEICA can use in print and on its website. Recognition for the relevant member company is provided in the form of references to the company's own, more comprehensive communications materials in a PDF."

#### **The format of a good practice story comprises a short bulleted description of:**

- The sustainability benefits of the end product or process improvement.
- The role played by the adhesive or sealant or process improvement.
- What is new about the development.

It also includes a diagram and a takeaway of the key points in bold at the bottom.

This is all done without mention of any company or product names. Then, for more details, readers are directed towards the member company's own materials in a PDF.

From the PDF, readers will be able to link back to the list of FEICA good practice stories or to the member company's website.

Heinz-Werner Lucas continues, "The good practice stories are adhesive and sealant 'enabling' stories, demonstrating how a small amount of an adhesive or sealant, or a process improvement, can lead to a substantial environmental benefit. However, it is essential that these are genuine articles detailing real benefits. 'Greenwashing' articles will definitely not be accepted."

### **First four Good Practice stories published**

These are:

- Adhesives for Sustainable Development: Adhesives for Lightweight Furniture (from H.B. Fuller).
- Adhesives for Sustainable Development: Adhesive for External Thermal Insulation Composite Systems (ETICS) (from Mapei).
- Sealants for Sustainable Development: Environmentally responsible 1-Component Sealants (from Sika).
- Adhesives for Sustainable Development: Paper glues based on plant-based raw materials, packaged in plant-based raw materials (from Bolton Adhesives).
