# Generic Approach to Risk Management (GRA) explained

## The extension of the generic approach to risk management (GRA) proposal

The Generic Approach to Risk Management (GRA) is an accelerated process to ban certain chemicals based on their hazardous characteristics, regardless of whether there is any actual risk present.

This accelerated process is already in place for CMRs (Carcinogenic, Mutagenic and Reprotoxic chemicals) in consumer mixtures; however, with the revision of REACH, the European Commission would like to extend the scope of application to additional hazard classes, and from consumers to professional users.

## Impact of the proposed extension of the GRA

Professional workers need chemical products to perform tasks that are important for society and the circular economy. Thanks to the chemistry of professional adhesives and sealants, high-performing, durable products can be manufactured in many industries.

The application of the generic approach would adversely affect the availability of certain substances and products. Construction workers or workers in repair shops, for instance, would have to work with consumer products that do not have the technical functionalities required for professional applications. The range of potentially affected uses is enormous, and the extension to additional hazard classes exacerbates the problem.

Furthermore, many adhesives and sealants are enablers of the European Green Deal's Circular Economy Action Plan. The extension of the generic approach to risk management could limit the realisation of the circular economy where professional uses of adhesives and sealants provided solutions easy to recycle.

## **FEICA** proposal

FEICA considers the extension of the generic approach to risk management to professional uses inappropriate and disproportionate. The use of chemical products by professional workers differs considerably from that by consumers and should, therefore, not be subject to the same restrictions or prohibitions. In fact, professional users have more characteristics in common with industrial users than with consumers.

FEICA promotes the development of a European platform for information and training of professional users securing the safe

handling of all chemicals. This initiative would be more proportionate than the generic ban of substances for professionals.
